- 1. Determine the staff member's Job Family. <u>Exempt</u> <u>Non-Exempt</u> <u>AFSCME</u> <u>POAM</u> <u>COAM</u> <u>Trades</u> <u>IUOE</u> <u>Nurses</u>
- 2. Determine eligibility.
- 3. Determine the number of Holiday hours and/or Season Time hours to which the staff member is entitled.
- 4. Determine hours worked for Week 1 and Week 2.
- 5. Plot the staff member's work schedule on the Christmas/New Year's Holidays & Season Days Worksheet.

- Holidays include New Years Day, Memorial Day, July 4th, Labor Day, Thanksgiving, the Day after Thanksgiving, and Christmas.
  - Holidays that fall on Saturday are observed on Friday, and those that fall on Sunday are observed on Monday. Exception: IUOE staff members observe holidays on the actual holiday. Season days are the four workdays between the days observed as Christmas and the New Year's Day holidays. Hospital AFSCME employees can report Season Time between Dec 15 and Jan 15.
