

**THE UNIVERSITY OF MICHIGAN – PAYROLL OFFICE**  
**REQUEST FOR EXEMPTION FROM FICA TAX WHILE WORKING ON PhD DISSERTATION**

During academic terms in which a student is enrolled half-time or more and holds a GSI, GSA, GSRA or temporary appointment, the payroll system automatically exempts the student from FICA withholding on wages paid for those appointments.

During academic terms in which a student is not enrolled or enrolled less than half-time, such as the Spring/Summer semester, the payroll system does NOT automatically exempt the student from FICA withholding.

When the following circumstances occur during the Spring/Summer semester, the student may request to be exempt from FICA withholding:

- Student is not enrolled or enrolled less than half-time;
- Student's wages result from a GSI, GSA, GSRA or temporary appointment;
- Student is actively working on her/his dissertation; and
- Student's faculty advisor attests that the student is working on his/her dissertation and making progress towards the degree during the Spring/Summer academic semester.
- Student has met all requirements for candidacy. Please note, pre-candidates are not eligible to be exempt from FICA taxes.

To request an exemption from FICA taxes, both sections of this form must be completed and signed.
